Comprehensive ExamPetention/Covid

- x In response to COVID, faculty reviewed SP20 semester content incommanded a SP20 comprehensive final. Students are making progress in FA20 content
- x Reported 2 out of 10 students completing program have not taken the boards.affects passing rate. Suggested Director reach out to the two students and work with Campion Funds to cover cost of exam, if needed.
- x Retention for class of 20214 admitted, 11 students maining (7 percent retention). Two students were academically lismissed and one switched out of RAD program Joint Review Committee on Education in Radiologic Technology (JR) (JR) EAST benchmark of 75 ercent retention rate.
